The matters in which Rob has been retained as a neutral cover the entire spectrum of civil litigation; professional liability, personal injury, premises liability, catastrophic loss, business dissolution, partnership disputes, employment litigation, real estate and land use contests, probate and estate disputes, and pretty much everything else in between. On average, attorneys specially retain Rob to mediate, arbitrate, or serve as a hearing officer more than 210 times per year.
