# **Privacy Policy**

Introduction and Agreement and Consent

NHD follows this Privacy Policy relating to the collection, use, and sharing of the information provided by your visits to the NHD website. NHD reserves the right and opportunity to revise this Policy periodically and without specific advance notice to you. #### **Electronic Information Collection**

The NHD website will deposit "cookies" onto your devices when you visit the website.
